Dear Chairman Rehberg and Ranking Member DeLauro:

The Agency for Healthcare Research and Quality (AHRQ) is transforming people's health in communities in every state around the nation. AHRQ funds the research and programs of your constituents at local universities, hospitals, and health departments that improve health care quality, enhance consumer choice, advance patient safety, improve efficiency, reduce medical errors, and broaden access to essential services. To expand AHRQ's capacity to generate this important science, the Friends of AHRQ urges you to provide the agency a base, discretionary budget of \$400 million in FY 2013.

Finding new ways to get the most out of every health care dollar is critical to our nation's fiscal health. We spend more than \$4 trillion annually on health care, with the federal government purchasing the largest share through Medicare, Medicaid, Federal Employees Health Benefits Plan, TRICARE, and veterans' health care. Health services research tells us that as much as 30 percent of this \$4 trillion—\$1.2 trillion—is wasteful or ineffective. Too many Americans receive care that is not of as high quality as it could be. We can do better, and AHRQ-funded research can show us how.

AHRQ's mission is to generate the evidence necessary to build a high-quality, high-value health care system. This science provides consumers and their health care professionals with valuable information to make the right health care decisions for themselves and their families. AHRQ's research also provides the basis for protocols that prevent medical errors and reduce hospital-acquired infections, and improve patient confidence, experiences, and outcomes in hospitals, clinics, nursing homes, and physician offices.
